

About the Resilient Georgia Regional Grants

This section has been completed for you.

<u>Resilient Georgia</u> has been working with 16 regions across Georgia to provide an emphasis on trauma informed awareness and care, Adverse Childhood Experiences (ACEs) and child sexual abuse prevention training as a basis to transform systems and procedures crossing both public and private sectors.

- Resilient Georgia serves as a supportive and guiding resource during each region's planning and implementation process.
- These regional action plans each address the behavioral health needs of individuals birth through 26 years old and families in the community and surrounding counties using the Collective Impact framework (a diverse, robust and well-planned public-private partnership).
- Trauma Informed Care, ACEs and child sexual abuse prevention can be the basis for systemic changes in a community. Each region has identified how one or more of these content areas are delivered to diverse community members through formal training, education, marketing and communications.
- Round 1 grants were awarded in Nov 2019 to regional coalitions based out of Athens,
 Augusta, Macon, Savannah and surrounding areas. Round 2 grants were awarded in July
 2020 to regional coalitions based out of Albany, Columbus, Rome, Thomasville and
 surrounding areas. Round 3 grants were awarded in March 2021 to regional coalitions
 based out of Clayton, Cobb, Gwinnett, Valdosta and surrounding areas. Round 4 funding
 was awarded in December 2021 to regional coalitions based out of Brunswick,
 Chattahoochee Valley, Northeast Georgia and Waycross and the surrounding areas.

The ACSRI Coalition focuses its efforts on authentically engaging stakeholders from various sectors of the Clayton County community using culturally tailored tools and strategies to raise awareness of (and prevent) ACES. **The Many Faces of Trauma** was developed as framework for characterizing the many forms of trauma that minority youth and their families negotiate daily. Our coalition's work is centered around creating spaces for honest discussions about the impact of racism, marginalization, and generations of familial trauma on youth and families; and the infusion of culturally tailored evidence-based practices into the various sectors of the Clayton County. Collectively, our efforts are designed to respond to existing trauma and prevent future trauma.



Efforts to prevent ACES in marginalized minority communities must intentionally address the complex (commingling) factors that impact community trauma. ACES are often exacerbated by issues of structural and contextual racism, disparate health and social outcomes and the pervading "culture of silence" and shame in communities where Black and Indigenous People of Color (BIPOC) are the majority. Efforts to engage communities like this must be intentional about empowering that community to craft its own narrative around difficult conversations while celebrating the inherent resilience that also exists therein.

GCAPP and CHS hosted two Resilient GA Connect Matter trainings and one coalition meeting in October to support the efforts of Resilient Clayton. Partners had an opportunity to give input and feedback on the next steps as it relates to Resilient Clayton's next steps, including\ having more frequent coalition meetings to support Clayton's immediate community needs. Coalition partners are being tasked with identifying new coalition members that should be at the next coalition partner meeting. The coalition team is in the process of establishing a regular cadence with meetings and being sensitive to the community's immediate needs (i.e. COVID, mental health, transition due to COVID, etc.)

Advocacy and Policy

During this reporting period, much of the work for Resilient Clayton was focused on faith-based and community based institutions. Coalition members were tasked with identifying opportunities to begin infusing Connections Matter and Stewards of Children into the daily operations of youth serving/youth supporting agencies in their circles of influence. Coalition partners in the faith-based community have stepped up and agreed to begin encouraging their network of churches to begin incorporating Connections Matter and Stewards of Children Training in youth ministries and affiliated youth program volunteers and staff. Given that our



partners lead an extensive *network* of churches, the opportunity to promulgate evidence-based ACES training countywide is promising.

Next steps include establishing and identifying more coalition members from various sectors of the Clayton County community that includes law enforcement, school-based connections, parents overall. The coalition members have recently been tasked to provide additional linkages to these other stakeholders that can benefit from our Connect Matter and Stewards of Children training in the months to come.

Research

- At GCAPP we apply a range of quantitative and qualitative evaluation techniques for each of our programs. For ACSRI, we will leverage culturally responsive and participatory evaluation approaches to involve program staff, program participants, racially and culturally diverse key-informants, and other stakeholders with high interest and low levels of power in evaluation design, data collection, analysis, and reporting.
- Based on the range of perspectives that inform the Clayton community's evaluation questions, we've selected the best methods to inform these questions and have captured these in the evaluation plan.
- While we tailor evaluation to unique program needs, there are a set of shared indicators we track across all programs to determine our organizational impact. At the start of each program, we collect demographic information such as race/ethnicity, gender, and sexuality to understand who we are currently serving and the population we haven't yet reached. As a capacity building organization, we will also collect a reasonable amount of process data for such as recruitment, retention, and program completion rates which will be useful in determining ACSRI's reach.
- Finally, to assess broader impact we conduct pre and post knowledge assessments and/or check-ins/ semi-structured interviews with program participants to determine changes in knowledge, skills, and behavior as a result of our programming.
- So far, community partners in Clayton have provided feedback to the evaluation plan and are in the process of scheduling activities. Once these dates are established, the team will coordinate the corresponding data collection activities.

- Connections Matter Train-The-Trainer course on Tuesday 9/21 (CHS, Ms. Taylor Bryan)
- Stewards of Children Training 9/22 [CHS, Ms. Taylor Bryan, (former) Senior Consultant]
- Community Resiliency Teacher Trainings 10/20 -10/22; 10/28th-10/29th [CHS, Ms. Taylor Bryan, (former) Senior Consultant]
- Connect Matter Training provided 11/16th and 11/17th to four people virtually [CHS, Ms. Taylor Bryan, (former) Senior Consultant]
- Resilient GA Clayton provided Connect Matter training December 16th and there were 5 people in attendance virtually. The session was led by Ms. Angel Young, M. Ed, GCAPP's Sr. CBI Program Manager. The next step is to train Resilient Clayton's coalition members on the Connect Matter training. Resilient Clayton had a wonderful introductory planning meeting during the month of October to gather interest in the Resilient Clayton project overall. There were approximately 19 individuals from the Clayton County Service area and all were interested in learning more about the Resilient Clayton project.

Innovative Partnerships

Engaging the faith community as a key partner with highly visible, widely respected minister/servant leadership to spearhead engagement efforts, was innovative for this county. In Clayton County, traditional approaches to key stakeholder engagement are often hampered by local politics, history and or personal agendas. Identifying individuals with no clear affiliation to



one political or social group, who are affiliated with the faith-based community as a whole and actively engaged in the social and civic fabric of the community, proved a tremendous resource. The servant leader engagement strategy enabled the Project Team to systematically identify influential like-minded local leaders who were genuinely interested in making a difference and were willing to lay personal agendas to the side for the greater good of the project. Arguably, it could have been considerably more difficult to draw in local stakeholders if the messengers were not trusted servant leaders from the faith community.

Spotlight

During our first coalition meeting in October, members of the coalition began to discuss some of the challenges that they were having themselves as it relates to parenting and the pandemic. Coalition members indicated that they too need additional support services as it relates to the COVID pandemic and support services to get them through their mental health. Coalition members discuss how important projects like Resilient GA are to help move the work throughout the community. The coalition members had representation from various sectors throughout the Clayton community which included law enforcement, Social Workers, Clinical Counselors, Educators, Local clergy members and a host of other agencies that represent the community.

Some of the main takeaways were that more individuals should be at these coalition meetings to support the much needed work within the Clayton County service area. Members mentioned that they were willing to continue to support any efforts that are needed to ensure that individuals learn more about the training and to support the overall initiatives of Resilient GA overall. THE ACSRI project team spent a considerable amount of time unpacking "how" best to characterize trauma in the Black community and how to create a common language that properly characterized ACE. This characterization had to intentionally (and authentically) frame the ACES conversation within the context of the historical and contextual experiences of minority county members. It appears that our approach is opening doors and creating safe spaces for open and honest dialogue that rarely (if ever) occur.
